In addition, the holder is entitled to receive additional shares of common stock equal to the original purchase price per share (\$3.8048) divided by the price to the public of the shares of common stock issued in the Issuer's initial public offering and these shares accrue a dividend that is payable-in-kind in shares of the Issuer's common stock

3. The securities do not have an expiration date. The securities convert automatically into shares of the Issuer's Common Stock on a one-for-one basis in connection with the closing of the Issuer's initial public offering.

4. Represents securities held by Stifel Nicolaus Custodian FBO Richard J. Nigon SEP IRA Acct.

5. This option vests as follows: 553 shares vested on December 5, 2012, and the remaining shares vest as to 553 shares each month commencing on January 1, 2013 and continuing until this option is fully vested.
